Chair Report - Bill Robe.

Bill Robe opened the meeting with general discussion of expectations of CAG and how CAG might be restructured to be more efficient and effective in representing the CAG stakeholders.

E&S Ring:

UGCAM Property Management-Jake Friesen:

- 1. Governors Guidance for higher education institutions mandates University Glen residents must maintain separation from CSUCI Students. UGLen residents are restricted from access to the quads, Broome Library and other CSUCI facilities.
- 2. During mid-August residents reported unexplained lights flickering and worked with SCE and Eastman Electric to identify problem.
 - a. It appears to be resolved by SCE
 - b. All owners experiencing this were recommended to call SCE directly'
 - c. Three slab leeks and two domestic water leaks were reported and may be related to high water pressure. Water pressure regulators to be installed.
 - d. Tom Bokhart ask why Kennedy Wilson installed water pressure valves at the apartments, B. Gordon reported that low flow aerators (not pressure regulators) were installed to lower water consumption.
- 3. Irrigation System repairs moving forward.
 - a. T. Bokhart mentioned the irrigation system had been poorly maintained by Facilities Services. Costs were inherited by residents.
 - b. DG Path The DG path was damaged by a water overflow during water tower maintenance by Facilities Services.
 - i. UGCAM obtained bid from Brightview to repair.
 - ii. Pathway used often by the community and residents expect the responsible party to repair the damage or reimburse for cost of Brightview to repair.
