John Lazarus called to order at 4:02pm

Kennedy Wilson (Doris Kelly):

- A. Doris Kelly is the Project Manager for Kennedy Wilson and Anacapa Canyon.
- B. The new electrical around the recently closed roundabout finished this week.
- C. Dry utilities and paving for phase 1 will begin August 1st.
- D. Rough grading for market rate apartments began.
- E. Construction for market rate apartments will begin August 15th.
- F. McCarthy General Contractor is selected to be the contractor for Phase 1.
- G. The main priority for Kennedy Wilson is the vertical construction for senior housing.
- H. Construction team continued to work Saturdays through the summer to keep up with schedule.
- I. Mary Kennedy expressed her concern for water supply and pressure with Anacapa Canyon.
- J. Mrs. Kelly assured her two engineering firms have done the reports to ensure there will be enough water pressure for everyone.
- K. Mark Hewitt expressed his concern for the Anacapa Canyon three-story building along the road.
- L. John Lazarus assured Mr. Hewitt there will be greenery behind the building and along the street.

Site Authority (John Lazarus):

- A. Gothic landscaping is the new landscaping company for University Glen
- B. The Safety Fair will be on a Saturday in October.
- C. The University Bookstore agreed to stock red cross emergency kit items.
- D. Ventura County Fire Department and Campus Police Department will attend.
- E. John Lazarus has approval from the HAC Board to draft up an agreement for solar panels on townhomes.
- F. Clarifying Priority system to include part time employees of CSUCI.
- G. Working on creating an owner's manual to accompany the Ground SubLease.
- H. Goal is to simplify the Ground SubLease into a document homeowners and future homeowners can easily read and comprehend.
- I. Mr. Lazarus shared some statistics on home sales and price of home sales in University Glen compared to Camarillo.
- J. Mr. Lazarus stated that 30.51% of homes are owned by someone who is currently or recently retired CSUCI employee.
